Dan had passed the baton to Betsy regarding the bayou clean up, and she gave an update that she spoke with Diane Kennedy (city staff) and that there is a follow-up meeting arranged. With Betsy's approval, Ron will help with the bayou effort.

Cindy offered to help maintain and redesign the LPNA Web Site. Ron will provide credentials.

The recent neighborhood party, Picnic in Park, was discussed. All agree that that it was a success, even though it was cut short by rain. The format of folks bringing their own blankets/chairs will continue with future parties, since it also made cleanup significantly easier.

Matt met with city staff to discuss repairs to the roads and sidewalks. Next steps are a need to identify specific streets/cross walks for city to prioritize & also for going after additional funds.

Ron gave an update on the recent fencing the city placed around the Payne Park Auditorium. The city is going to remove a portion of the fencing and reduce the remaining sections.
